- Video Meg Lojek/McCall– nothing to report will take Kerri off of DVD rotation. Timbra cleaned the DVDs. Meg will check to see if money in budget to replace cleaning supplies for Timbra. Melanie will let Timbra know where to send audio books since it supposed to be Kerri Hart.
- Idaho Digital Consortium Sherry Scheline/Donnelly reported that audio book circulation higher than ebooks. Will have another fall meeting stay tuned. Need a policy to handle complaints for contested books and magazines Sherry Scheline will continue to handle. Some libraries have IPads available to patrons to view magazines in the library. Sherry also reported that Idaho Digital Consortium is the largest in the nation with the most libraries working together we are setting a precedence.
