- One of these is the **Foundation Directory**. This is a grant search platform. Libraries can create a free account for basic searches for grants. It is a possibility that we could pay for a more professional subscription as a consortium.
- The second one we discussed was **Creative Bug.** This has a free 60 day trial period. If anyone is interested in doing this trial period and come to the next meeting prepared to share their thoughts about subscribing to this platform as a consortium, we would appreciate.
- The third platform we talked about is **Kanopy**. Meg, from McCall, is looking into this platform for us, but if anyone else has any experience using Canopy we would love to hear from you.
